GMM MINUTES: February

Minutes from the JLCR General Membership Meeting Tuesday, February 16, 2010

Welcome

Mindy Sorg called the meeting to order at 7:05 pm and welcomed the membership by sharing a note from Families Helping Families thanking Junior League for the Valentine's themed skate party that was held for local foster children earlier this month. She also read some historical facts about Junior League's early years. Abbie Covenah called for an approval of the January meeting minutes. The minutes were approved by the membership.

Promoting Voluntarism

Done in a Day (DIAD)

Amy Graham thanked the membership for their participation in the Valentine's Day party for Families Helping Families. They had 167 kids and 58 adults attend. The March event, Kids in the Kitchen, will be held with YPN. It will take place March 9 at First Lutheran Church.

Developing the Potential of Women Education & Training

Emily Ernst introduced Sue Bentley from the League of Women Voters. Sue spoke about her experiences in the League of Women Voters over the last 30 years. She also spoke about early attempts by women in Iowa to attain the right to vote for women.

February GMM Sponsor

Sarah Tenley introduced the February GMM sponsor, Mary Locher. Mary organizes the Wee Tail, a seasonal children's consignment sale that is held at Hawkeye Downs.

Nominating

Lori Houston announced that the ODI attendees will be Tara DeWolf and Andrea McVay. Lori then reviewed the 2010-2011 slate and asked the membership to approve the slate through a verbal vote. The 2010-2011 slate was approved by the membership.

Finance: Save Plan Spend

Kymm Barnes spoke about the Save, Plan, Spend concept. Junior League implement this way of managing our finances beginning in the 2010-2011 year. Kymm distributed copies of the budget and a summary of our current account. She noted that we currently use one main budget. To begin the Save, Plan, Spend concept, we will begin to use two budgets. Ultimately, the number of accounts will not change, but we will break our one budget into two: the support budget and the community outreach budget. The support budget will be funded by member dues, the annual fund, and endowment interest and will go toward the administrative costs of running the organization. The community outreach budget will be funded by fundraisers and will be restricted to activities more directly related to our mission. This two budget structure will help us to focus on building funds for our philanthropic projects prior to making large financial commitments.

Initially, the dollars available in the community outreach budget will be based on an average of the balance of the project account and the total profit from the fundraisers. Later, we will be able to calculate the community outreach budget based on a rolling average from past years.

Kristin Roberts asked if there was a marketing plan to explain this concept to the community. Marcy Dent feels that there is potential to focus on our volunteers instead of our funding for the being. Ann Olson pointed out that Junior League is currently known for our fundraisers and this would be a way to draw more attention to our projects.

Kymm's presentation is on the OFF if anyone is interested in looking at it further.

Ways & Means

Kristin Roberts presented the Ways and Means proposal for 2010-2012. She began by explaining that JLCR does not have a 2011 LTTC purse sponsorship committed at the moment. However, our current sponsor is interested in continuing his sponsorship, but will not make a final decision until this summer's event. The ways and Means committee feels that it will be more prudent to delay the LTTC vote until July so that we will know if we will have a purse sponsor at the time of the vote. To be able to move forward, the Ways and Means Committee proposed that we continue with the Annual Fund and Butterfly Kisses. In addition to these events, they also proposed that we begin a Life Skills "Playshop." The Playshop will be held at four different elementary schools and will take place on two different Saturdays. This fundraiser is projected to raise \$9,120 over two days and will give members more opportunities for fundraising hours. There is also potential to hold more of these Playshop events throughout the year to generate more revenue. The Ways and Means committee proposed that JLCR delay the LTTC vote until July 20, 2010. They also proposed

that for 2010-2012, we vote in the Annual Fund Solicitation, Butterfly Kisses, and the Life Skills Playshop. In addition, the committee also proposed that at least three fundraising hours must come from volunteering at LTTC. There will be a Q&A session in the fireside room on March 16th from 6:30 to 7 p.m. The vote on the Ways and Means proposal will take place at the March GMM.

Kristin also announced that Annual Fund campaign has reached \$6,122 with 65.5% participation from the actives and 21% participation from the sustainers.

Membership Activity

Cristiane Abouassaly facilitated a membership retention activity. She also asked members to complete the membership survey that was recently distributed via email and reminded everyone that the April meeting will be Bring a Friend to League night.

Mindy also announced that GMM announcements are now due to her by Sunday night before each GMM.
